Pachinko market and pachislot market shrank about 11% and 32%, respectively, year on year.

The Group recorded higher sales and higher profit, with increased shares of both pachinko and pachislot markets (pachinko about 12% and pachislot about 4%).


## パチンコ機 販売シェア (台数ベース)




